The School is expected to see all circulars on these CBSE websites regularly.

12. The optimum Section teacher ratio of 1:1.5 as well as student teacher ratio of 30:1 is to be maintained to teach various subjects and school shall appoint
13. qualified and trained teaching staff on regular basis as per provisions of Affiliation Bye Laws of the Board.
Every affiliated school shall sponsor regularly its bonafide and eligible students in Boards Class X and Class XII examinations from the year
14. mentioned while granting affiliation/up-gradation regularly without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates.
Running of coaching institutions in the school premises in the pretext of
15. providing coaching to the students for various examinations is not permitted by the Board. Strict action would be taken on defaulters.
The Manger and the Principal of the school shall be jointly responsible for the
